

AMENDMENT #3
to
Agreement # 2021-083 Public Sector Procurement Consulting Services

This AMENDMENT (“Amendment”) to the Services Agreement #2021-083 (“Original Contract”) is made and entered into effective the date of last signature below by and among the NORTH CENTRAL TEXAS COUNCIL OF GOVERNMENTS, a Texas political subdivision and non-profit corporation, hereinafter referred to as “NCTCOG”; Civic Initiatives, LLC, the original service provider under the Original Contract, hereinafter referred to as “Assignor”; and GLI Capital Group, Inc., d/b/a Public Knowledge, LLC, hereinafter referred to as “Assignee” or “Service Provider.” NCTCOG, Assignor, and Assignee are collectively referred to herein as the “Parties.”

WHEREAS, NCTCOG and Civic Initiatives, LLC, entered into the Original Contract on **March 1, 2022**; and

WHEREAS, Section 9.13 of the Original Contract requires a party to obtain the written consent of the other party before assigning the Original Contract; and

WHEREAS, Section 9.15 of the Original Contract allows for amendments; and

WHEREAS, the Parties agree to amend the Original Contract in accordance with the terms of the Original Contract, as well as the terms provided herein.

NOW, THEREFORE, in consideration of the mutual covenants expressed herein, NCTCOG, Civic Initiatives, LLC, and GLI Capital Group, Inc., d/b/a Public Knowledge, LLC mutually covenant and agree to:

1. NCTCOG consents to the assignment of the Original Contract by Civic Initiatives, LLC (“Assignor”), with a previous address of record of 7000 N. Mopac Expressway, Suite 200, Austin, Texas 78731, to GLI Capital Group, Inc., d/b/a Public Knowledge, LLC (“Assignee”), effective as of the date of last signature below.
2. Assignee assumes and agrees to perform all duties, obligations, and responsibilities of the Assignor under the Original Contract arising on or after the effective date of this Amendment. Assignor remains responsible for any obligations, liabilities, or claims arising before the effective date of this Amendment, unless otherwise agreed in writing by NCTCOG.
3. From and after the effective date of this Amendment, all references in the Original Contract to Civic Initiatives, LLC or the Service Provider shall mean GLI Capital Group, Inc., d/b/a Public Knowledge, LLC, and all notice, contact, reporting, invoicing, and payment information shall be updated to reflect GLI Capital Group, Inc., d/b/a Public Knowledge, LLC at the address and contact information stated above.

This Amendment binds and benefits the Parties and any successors or assigns. This document, including the Original Contract, is the entire agreement between the Parties.

All other terms of the Original Contract remain unchanged and in full force and effect.
