

**RESOLUTION AUTHORIZING CONTRACTS FOR ARTIFICIAL INTELLIGENCE (AI) LANGUAGE TRANSLATION, TRANSCRIPTION, AND QUALITY CONTROL SERVICES**

**WHEREAS**, the North Central Texas Council of Governments (NCTCOG) is a Texas political subdivision and non-profit corporation organized and operating under Texas Local Government Code Chapter 391 as the regional planning commission for the 16-county North Central Texas region; and,

**WHEREAS**, NCTCOG is a voluntary association of, by and for local governments established to assist in planning for common needs, cooperating for mutual benefit, and coordinating for sound regional development; and,

**WHEREAS**, a Request for Proposals (RFP) 2025-093 for Artificial Intelligence (AI) Language Translation, Transcription, and Quality Control Services was advertised and proposals received on July 14, 2025; and,

**WHEREAS**, proposals were evaluated by a committee comprised of member agencies; and,

**WHEREAS**, following evaluation, it is recommended that contracts be awarded to Compunnel Software Group, Inc., Convey911, GovWorx, Inc., Invictus Apps Inc., dba Prepared, and Northland and Companies, dba Northland Business Systems; and,

**WHEREAS**, these contracts are intended to be utilized by NCTCOG member governments and other participating entities as part of NCTCOG's TXShare Cooperative Purchasing Program; and,


**WHEREAS**, NCTCOG has complied with federal and State regulations regarding contract and procurement proceedings for this procurement 2025-093.

**NOW, THEREFORE, BE IT HEREBY RESOLVED THAT:**


**Section 1.** Contracts between NCTCOG and Compunnel Software Group, Inc., Convey911, GovWorx, Inc., Invictus Apps Inc., dba Prepared, and Northland and Companies, dba Northland Business Systems, for Artificial Intelligence (AI) Language Translation, Transcription, and Quality Control Services for the service categories detailed in Attachment 1, for maximum five (5) year terms, be and are hereby approved.

**Section 2.** The Executive Director or his designee is authorized to execute necessary agreements to carry out this program, including agreements with member governments and other entities wishing to participate in NCTCOG's TXShare Cooperative Purchasing Program, in the name of the North Central Texas Council of Governments.
