Further, submission instructions have been amended with the following text to allow the option for proposals to be mailed or delivered to the NCTCOG office located at 616 Six Flags Drive, Arlington, TX 76011. Note that this is an alternate, *non-mandatory* submission option to the original submission method of uploading proposals to Public Purchase. **Bold-face type indicates a change.**

Submission of all proposals shall be made in English, in searchable PDF format, and must be ~~uploaded via Public Purchase~~ **received** no later than 2:00 P.M. (Central Standard Time) – Tuesday, **August 1, 2023, regardless of chosen submission method.**

**Proposals may be submitted in one of the following ways:**

1. Upload to Public Purchase Website
